1 INTRODUCTION

The General Product Safety Regulation (GPSR), adopted on 10 May 2023, marks a significant update to the EU's consumer product safety framework. It replaces the General Product Safety Directive (2001/95/EC) and aims to modernize safety rules in response to evolving technologies, online marketplaces, and global supply chains. This regulation ensures that all consumer products placed on the EU market—whether sold online or offline, new or second hand—are safe for use. It introduces directly applicable rules across all Member States, eliminating inconsistencies in national transpositions. Key motivations for the GPSR include:

- Adapting to digital and online sales channels
- Strengthening market surveillance and enforcement
- Enhancing consumer protection and recall effectiveness
- Addressing cybersecurity and Al-related risks in products

The GPSR also introduces the "Safety Gate" (formerly RAPEX), a more robust EU-wide alert system for dangerous products, and places greater responsibility on economic operators (manufacturers, importers, and online platforms) to ensure product safety throughout the lifecycle.

2 QUESTIONS

2.1 Does the Recreational Craft Marine industry fall within the scope of the EU Regulation 2023/988 on General Product Safety (GPSR) and if so, are marine propulsion manufacturers required to comply with its accident reporting obligations?

Regulation (EU) 2023/988 on GPSR entered into force 12th June 2023 and applies from 13th December 2024. This regulation applies to consumer products, including equipment intended for recreational crafts. For products subject to specific safety requirements (by Union harmonised legislation), the GPSR applies to aspects and risks not covered by those specific safety requirements. The Recreational Craft Directive is listed in Reg (EU) 2019/1020, which focuses on market surveillance and compliance of products. Therefore, accident reporting to authorities by the manufacturer is an additional mandatory requirement that seems to apply to components and products installed on recreational craft.

Article 20 of the GPSR on Obligations of economic operators in the case of accidents related to safety of products is included in Chapter III Section 2, hence it applies also for recreational crafts. This is relevant to accidents involving personal injuries and/or death caused by the product. 'Distributors' are responsible to report accidents to the 'manufacturer'. Manufacturers need to report accidents involving injuries and death caused by our products through the Safety Business Gateway¹.

For components or vessel types not covered by the RCD, such as hydrofoiling vessels, which are explicitly excluded under Article 2.2 of the RCD, the full GPSR applies.

Under Article 27 of the GPSR, the Safety Business Gateway serves as the official portal for economic operators (e.g., manufacturers, importers) to provide required safety information to Market Surveillance Authorities (MSAs) in a streamlined and accessible manner. As clarified by the European Commission during the webinar held on 30 January 2025² and as per Recital 68, "if a business (...) is aware of an accident caused by one of its products, the business has to notify the responsible national authorities through the Safety Business Gateway and take action to prevent harm"³.

In accordance with Articles 25 and 26 of the GPSR, the Safety Gate Rapid Alert System is designated for use by Member State authorities to notify the European Commission of serious risk cases. These notifications must be submitted within four working days following the adoption of a corrective action. The Commission is then required to review the notification within the same four-day timeframe. Authorities must also inform the Commission of all other corrective measures, using the appropriate information tool of their choice.

For consumers, a separate Consumer Gateway is available to report safety concerns or incidents directly.

2.2 What constitutes an accident under the GPSR?

Under the scope of the General Product Safety Regulation (EU) 2023/988 (GPSR), an "accident" refers to incidents that result in death, serious adverse effects on a person's health, or injury—whether permanent or temporary. This includes bodily harm, illness, and chronic health conditions linked to the use of a product. Damage to the craft alone, without any impact on human health or safety, does not qualify as an accident under the GPSR.

In cases where an individual falls overboard or disappears from a craft, the incident may suggest injury or fatality. However, if such an event is not attributable to a product safety issue, it is our understanding that the marine propulsion manufacturer is not responsible for reporting the incident⁴ under the GPSR framework.

2.3 What does accidents 'associated with the use of the product' mean?

An accident is considered to be associated with the use of a product when it occurs on a recreational craft fitted with the product, and there is a reasonable possibility that the product caused or contributed to the incident. Importantly, it is not necessary to confirm that the product definitively caused or contributed to the accident before submitting a report. Such conclusions can only be drawn following a formal investigation. At the time of notification, the manufacturer is not expected to determine or declare the root cause of the accident. The obligation to report is triggered by the potential link between the product and the incident, not by confirmed causality.

2.4 What is an 'injury' with 'serious adverse effects'?

In line with interpretations such as those used by the U.S. Coast Guard, an injury with serious adverse effects refers to any injury that requires medical treatment beyond basic first aid. This typically includes incidents that result in a person being hospitalised, undergoing surgical intervention, or receiving specialist medical care⁵. Such injuries go beyond minor cuts, bruises, or temporary discomfort and indicate a significant impact on a person's health, whether short-term or long-term.

2.5 Does the requirement for accident reporting apply only within the European Union?

The accident reporting obligations under Regulation (EU) 2023/988 (GPSR) apply only to incidents that occur within the territorial waters of the European Union. Accidents that take place outside EU jurisdiction are not subject to reporting requirements under this regulation. Furthermore, accident reporting is not applicable in cases where the vessel is being:

- Used outside its intended purpose, or
- Operated for illegal activities

Only accidents involving legitimate use of the product within the EU are within the scope of the GPSR reporting obligations.

2.6 When should the marine propulsion manufacturer report the accident?

Under Article 20 of Regulation (EU) 2023/988 (GPSR), a manufacturer must report an accident "without undue delay" from the moment they become aware of it. This means that once the manufacturer is informed, typically by an importer or distributor, they are expected to act promptly and proactively. In practical terms, this is generally understood to mean within the first working week after being notified of the incident. The regulation does not require confirmation of the product's role in the accident before reporting. The obligation is triggered by the potential link between the product and the incident.

2.7 What should the be the contents of the report?


When submitting a notification to the competent authorities under Regulation (EU) 2023/988 (GPSR), the manufacturer must include the following key information:


- Identification of the product, including type, model, and any relevant serial or batch numbers
- Description of the accident, including the circumstances under which it occurred, if known
- Any available evidence suggesting the product may have caused or contributed to the incident
- Details of corrective actions already taken or planned, if applicable

It is not necessary to confirm the cause of the accident at the time of reporting. The obligation is triggered by the potential link between the product and the incident. All reports must be submitted via the Safety Business Gateway⁶, the official EU portal for manufacturers and other economic operators to communicate with Market Surveillance Authorities.

Any product sold directly to consumers, including through online platforms, falls under the scope of the General Product Safety Regulation (EU) 2023/988 (GPSR). This includes accessories and components such as fuel filters or fuel tanks that are intended for use in recreational craft.

If such a product:

- Has not undergone a proper risk assessment, and
- Can be installed incorrectly, leading to potential hazards (e.g. fuel leakage onto hot engine surfaces),

then the manufacturer has an obligation to:

- Conduct a thorough risk assessment,
- Provide clear installation instructions, and
- Inform consumers of any associated risks.

The GPSR introduces additional requirements for consumer products, particularly those sold online, to ensure that consumers are adequately informed and protected. This includes ensuring that installation guidance is clear and that potential misuse or incorrect installation does not result in serious safety risks.
